CALL TO ORDER

Director Greenhouse called the meeting to order at 6:35 p.m. The meeting was convened on the La Contenta campus and by electronic platform using Microsoft Teams.

ROLL CALL

Karen Graley, Board Clerk, conducted roll call and declared a quorum.

PRESENTATION

Ken Chawkins, Consultant to National Demographics Corporation gave a brief PowerPoint presentation summarizing the four previous public hearings. The purpose of this fifth public hearing is for the Board of Directors to decide whether to adopt a resolution to implement elections by zone and which map will define those zones.

Director Evans responded to Mr. Chawkins' inquiry as to which map they feel best represents the healthcare district. Director Evans stated the board has taken in good faith the information his firm has provided to the board and are in consensus to choose the Purple-B map to best represent the interests of the communities of the Morongo Basin.

Based on discussions during the fourth public hearing which preceded this hearing on May 4, 2023, the Directors finalized their comments regarding the action item to adopt Resolution 23-03. Director Greenhouse called for the motion.

Motion 23-23: Motion made by Director Cooper to adopt Resolution #23-03 to transition Morongo Basin Healthcare District from district-wide election to zone-specific elections using the map labeled Purple-B to define those election zones; second by Director Evans.
