APPLICANTS MUST BE:

- A registered voter with primary residence within the boundaries of the healthcare District's voting-zone #3 as defined in the District's map. The map may be viewed on the District's website at MorongoBasinHealth.org/Board-Directors.
- Prepared to serve the four-year term of office through December 31, 2028. The Board of Directors meet monthly and receive a small stipend for their service. The board may convene additional special meetings as needed.

THE LETTER OF INTEREST AND QUALIFICATIONS SHALL INCLUDE:

- Contact information: phone and email.
- A statement that the applicant has voting status within San Bernardino County.
- Primary residence address within the healthcare District's voting-zone #3 as specified on its voting zone map.
- Experience related to community leadership, such as career-based experience, or serving on community boards and committees. Include contact information to verify such experience.
- Three personal references with contact information.
- A completed Fair Political Practices Act Disclosure Statement (IRS Form 700). The form can be found at fppc.ca.gov. Choose "Form 700 (through December 31, 2024)."

FILING DEADLINE FOR LETTER OF INTEREST:
